CIRCULAR

Subject:- Conduct of National level women sports competitions under Rajiv Gandhi Khel Abhiyan (RGKA) during 2014-15.

The undersigned is directed to refer to this Ministry's circular of even number dated 28.05.2014 on the subject cited above and to state that, the National level women sports competitions have been allotted to the different States as under:-

- 2. Rules of the competitions:- The competitions will be organized in accordance with the rules of the National sports federation concerned and applicable to the National sports championship for women and within the provisions of annual competitions under RGKA scheme.
- 3. **Size of the contingent:-** The size of the contingent of each State/UT including contingent leader permissible for participating in all 12 sports disciplines will be the same as given in "Guidelines for Conducting Annual Sports Competitions under RGKA" circulated vide this Ministry's circular number 8-17/MYAS/RGKA/2013 dated 19.05.2014.
- 4. **Minimum entry for National women sports competitions:-** There has to be atleast 08 entries from States/UTs for the competitions to take place. The competitions will not be held in the disciplines in which there are less than 08 entries. Hence States/UTs are requested to send their confirmation for participation, disciplines wise, as early as possible in the prescribed proforma enclosed at **Annexure-I** directly to the host States under intimation to this Ministry. Discipline wise details of the participants may be provided in the format given at **Annexure-I(A)**. The number of SC,ST and OBC participants may be given in **Annexure-I(B)**. The prescribed format of the Entry Form of participation is also enclosed at **Annexure-II**, which may be got duly filled in and brought at the venue of the competitions alongwith the data of participants in a CD. It may please be noted that no participant will be allowed to take part in the competitions, whose Entry Form is incomplete or who does not bring the duly completed Entry Form.
- 5. **Boarding and Lodging:-** Free boarding and lodging facilities for the participants and officials as per eligible number will be provided by the host states for maximum six days including four days of competitions and one day before and one day after the competitions.
- 6. **Travel Expenses:-** To participate in National level women sports competitions, actual expenditure on travel not exceeding 2nd class rail fare/ordinary bus fare will be reimbursed to the players. The above amount will be disbursed after following due procedures at the venue of the competition itself.

- 7. **Age for participation:-** The upper age limit would be 25 years as on 31st December, 2014. Original/attested copy of certificate showing the date of birth will have to be produced at the venue of the competitions for being eligible for participation.
- 8. Eligibility Conditions:- Women below 25 years of age as on 31.12.2014 are eligible to participate. The women, those employed with the Departments/Agencies of the Central/State Governments are also eligible to participate in the competitions and they may represent the State/UT which they belong.
- 9. Photographs of the Participants:- Two stamp size photographs of each player selected for participation in the National level women sports competitions may be sent to the concerned department of host state through the contingent leader.
- 10. States Flag:- The States/UTs are requested to send two flags of the size of 6 X 4ft through the contingent leader for use in the march past and for hoisting at the main venue of the competitions.
- 11. **March Past:-** Trophies for the best and second best contingents in the March Past on the opening day would be awarded. It is requested that, proper kits may be provided to all participants and advise them to give smart turn out in the March Past on the opening and closing ceremonies.
- 12. **No Direct Entry:-** The Competitions should be conducted in progression. Direct entry of player/team at any level of competitions is not permissible. Prior permission of the Ministry of Youth Affairs & Sports should be obtained for participation of the contingent of such State/UT which did not conduct the lower level competitions.
