TERMS & CONDITIONS

- a) **Tenure:** The contractual engagement will be initially for a period of **Two years and extendable upto two more years** on the basis of satisfactory performance, periodic reviews, result oriented, etc. and at all times coterminous with the Khelo India Scheme.
- b) **Tax Deduction at Source:** The Income Tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment, for which this department will issue TDS/ Service Tax Certificates, as applicable.
- c) **Other Allowances:** No TA/DA shall be admissible for joining the assignment or on its completion. No other facilities like DA, Accommodation, Residential Phone, Conveyance Transport, Personal Staff, Medical reimbursement, HRA and LTC etc. would be admissible.
- d) **Extension:** Performance of the selected candidates would be continuously reviewed and their extension will be considered on the basis of periodic review/requirement.
- e) **Leave:** Selected candidates will be entitled for 30 days leave in a calendar year on pro-rata basis. Thereafter, candidates shall not draw any remuneration in case of his/her absence beyond 30 days in a year. Also unavailed leave in a calendar year will lapse and will not be carried forward to the next calendar year.

CONFIDENTIALITY

- h) The Secretary, Rajasthan State Sports Council, Rajasthan shall be the final authority in case of any dispute
- i) The appointment will be purely on contract basis and does not confer any right to claim to permanent employment in this Department.
- j) Any litigation matters pertaining to this engagement shall be restricted to the jurisdiction of the Jaipur courts.
- k) This department reserves the right to terminate the contract, by giving one month notice to Candidates.
- l) Owing to the requirement in this department, a list of panels may be drawn which will be valid for a period of one Year, this department reserve the right to cancel the panel without assigning any reason.
